SUVCW Battlefield Flag and Monument Policy

As approved during the 136st National Encampment - Lansing, Michigan, 2017

WHEREAS, we, as the descendants of Union soldiers, sailors and marines and revenue cutter servicemen who, as members of the Grand Army of the Republic, met in joint reunions with Confederate veterans under both flags in the bond of unity.

WHEREAS, we, as members of the Sons of Union Veterans of the Civil War strongly condemn the use of any American or Confederate flag by any and all hate groups.

WHEREAS, we the members of the Sons of Union Veterans of the Civil War strongly condemn the removal, defacement or destruction of any Civil War Veterans Monument or tablet, whether Union or confederate.

WHEREAS, we, the members of the Sons of Union Veterans of the Civil War, support the flying of all U.S. and C.S.A. flags at our National Battlefield sites and to be honored publicly in museums as our authentic archival documentation of our National past.

THEREFORE, we, the members of the Sons of Union Veterans of the Civil War are committed to teaching the history of the American Civil War in our educational system and ask that all descendants of Civil War participants join us in this endeavor.

LAST SOLDIER PROJECT HONORS ANOTHER VETERAN

Eel River Cemetery, Allen County, Indiana. – At 2 pm on Sunday, Oct. 15 of this year Champion Hill, Camp 17 sponsored another dedication and recognition of a county's last Union veteran to pass over to the great encampment of all old soldiers. Pvt. John Smith of the 44th Indiana Volunteer Infantry was the last Union soldier in Whitley County with his death in 1940. Private Smith was buried in Allen County in a cemetery just about a mile east of the county line. Brother John Eger of Champion Hill, Camp 17 was instrumental in arranging and setting up the ceremony and deserves a brevet for his good work. But Brother Eger would not want all the recognition for himself and is grateful for the help of many others in getting the project to its fitting end. Civil War re-enactment units, the 30th Indiana Volunteers and the 44th Indiana Volunteers were on hand as was the 5th Indiana Battery. The Whitley County Historical Society under Russ Gilliom supported the project and it was covered by the Columbia City paper. The Civil War Round Table of Northeastern Indiana was there and Margaret Hobson, who has written a 3 volume book on the 44th Indiana spoke about Private Smith specifically. Brothers from Somers Camp, #1 and Porter Camp, #116 were also on hand with wreaths to add to the ceremony. Camp 17 Brothers Rich McConnell and Eric Fricke provided music on the fife and drum, Brother Jim Kline acted as Chaplain. Camp 17 Commander Dave Tilden welcomed guests and Brother Alan Teller of Camp 1 gave a short address about the Last Soldier Project.



Last Soldier Project

Beginning in 2003, the Sons of Union Veterans of the Civil War embarked on the Last Soldier Project. The purpose of the project is to locate and appropriately mark the final resting place of the last Civil War soldier buried in each county/parish and in each state of this great country."(From our National website) This is one of the great projects of our order. It is a local project. As SVR members, we are often called upon to participate. It is a service to the community and brings history and the "boys in blue" alive and is a project all units should look forward to participating in. There are lots of counties/parishes.

Go to our National website - www.suvcw.org, ; click on "Projects & Preservation"; scroll to the bottom; look under "SUVCW Special Projects" and click on "Last Soldier Project". Scroll down to "Last Soldier Checklist". It will suggest how to get started and carry out a project. Click on "Last Soldier Ceremony" and you will have a ceremony that you may want to use.

Over the years I have participated in seven "Last Soldier Projects" both as a member of the SVR and as a speaker. This is a chronological listing:

May 1, 2006, Grant County, Indiana, Riverside Cemetery, John Christian Adams (8/17/1847-2/11/1949) Private Co. C 17 West Virginia Infantry. He was a drummer. He was the Last Soldier to die in Grant County and in Indiana. He was a member of GAR Magnolia Post #409.

June 10, 2007, Howard County, Indiana, Albright Cemetery, Gordon Williams (3/15/1848-3/27/1943) Unassigned PA Volunteers. He was a member of GAR Thomas J. Harrison Post #30. An interesting quote from the Kokomo Tribune, March 27, 1943, "At last Howard County's long dimming "line of blue" has faded out - faded out forever. It was 4:45 o'clock Friday morning, approaching the time for reveille. The call that came, however, was not for reveille, but taps. After all though, it was reveille – the reveille that announces the eternal morning."

Oct 18, 2008, Carroll County, Indiana, Burlington Cemetery, George W. Beck (10/23/1847-2/10/1942) Private Co. M 1st Indiana Cavalry.

November 11, 2009, Cass County, Indiana, Mt. Hope Cemetery, William A. Ziegler (8/17/1846-3/12/1942) Corporal Co. E 19th Ohio Volunteer Infantry. He was a member of GAR Logansport Post #14.

October 16, 2010, Miami County, Indiana, Converse Cemetery, William J. Rennaker (7/28/1846-1/12/1940) Private Co. A 25th Indiana Volunteer Infantry. He was a member of GAR W.A. Rayburn Post # 56.

October 15, 2011 Clinton County, Indiana, Bunnell Cemtery, Cyrus Clark (4/18/1846-7/22/1939) Sergeant Co. C 10th Indiana Volunteer Infantry. He was a member of GAR Stones River Post # 65.

October 15, 2017, Whitley County, Indiana, Eel River Cemetery, John W. Smith (11/2/1846-7/21/1940) Private Co. C 44th Indiana Volunteer Infantry. The attendance was much larger than expected.

CIVIL WAR SOLDIER'S PHOTO RECENTLY DISCOVERED:

In 1997 I began Civil War reenacting with some friends of mine at church. This rekindled my interest in Civil War history which made me think about the large portrait of a bearded man with a sword I remembered seeing at my grandparents' home as a teenager. In 1997, I asked my Uncles if they knew who that person was. They told me that it was my 2nd Great Grandfather, Andrew Gosnell and that their aunt had the portrait in her basement. My great Aunt gave the portrait to me in April of 2000. The 16 in. x 20 in. "crayon" portrait is an enlargement of a smaller photo of him. The picture frame was deteriorated and the portrait was broken into 3 major pieces and was crumbling. The portrait paper is on a heavy photo board that is acidic giving it a brownish hue. The wooden backing broke in three pieces causing the cracks in the portrait. On the back of the portrait written in cursive is "Mrs. Gosnell". Another unreadable name is on the back which we believe to be the Photographer or the business which may have enlarged it.

Ever since re-discovering the large portrait I've had hopes of someday finding the original photo of Andrew. I asked family members about its whereabouts, searched the internet, civil war shows and antique stores hoping that maybe it would be found.

On December 10, 2016, while going through my Uncle's estate, the original photo from which the large portrait was made was found by my cousin, loose in a box in an attic closet. I was filled with great excitement of the news and in January of 2017, I made the trip back home to see it for the first time. My hands were shaking when looking upon the very image my 2nd Great Grandfather posed for, over 156 years ago. The photo is a black lacquer tintype of irregular shape and measures 2-5/8 in. w x 3-1/4 in. h overall. It appears to have been held in a rectangular case at one time with a double elliptical (rectangular with round corners) mat due to the faint outline of where a mat was. His jacket buttons have been hand colored with gold paint as well as the reverse US on his belt buckle. A slight tinting of rose can be seen on his cheeks.

Andrew Gosnell mustered into the 31st Indiana Volunteer Infantry on September 20th, 1861. He was wounded in the hand at Shiloh, promoted to Corporal in July of 1862, was captured at Stones River on December 31st, 1862 and sent to Libby prison, was released 5 days after arriving at Libby prison and mustered out when his term limit was up in September 1864.
