### Minutes - Department of Indiana Mid-Year Encampment October 29, 2022

The 2022 <u>Mid-Year</u> Encampment, Department of Indiana, Sons of Union Veterans of the Civil War was held at the Penn-Harris-Madison Public Library, Mishawaka IN, October 29, 2022. Dept. Commander James Floyd opened the meeting at 9:37 AM.

Members of Co. D, 27<sup>th</sup> Indiana Infantry SVR presented the Colors.

The 2022 Department of Indiana Mid-Year Encampment was called to order by Commander Floyd. Commander Floyd welcomed our Sisters of the Allied Orders who joined us. He then introduced National Women's Relief Corp. President Elizabeth Thurston. Sister Thurston made a few brief remarks wishing a successful meeting to all

The Secretary called the roll of officers as follows:

Chaplain J. Alan Teller presented the opening prayer. Commander Floyd then welcomed all to the encampment. All recited the Pledge of Allegiance. He then introduced our National Representative Brother Bobby Welch, PCC.

Commander Floyd asked for a motion to approve the June 4, 2022 Department minutes. A motion was made by Brother Alan Teller that the minutes of the 136th Annual Encampment of June 4<sup>th</sup>, 2022 be accepted. The motion was seconded by Brother Bruce Kolb, there was no further discussion, the motion to accept the minutes as presented passed.

### Department Officers Reports:

Commander Floyd reminded the Encampment that we would not be reading the Department Officer reports. He noted that all reports submitted by the deadline were assembled and made available in advance for review. It was additionally announced that there were two (2) copies of the Officers reports available for review if so needed. Secretary Adams reported that all Department Officers Reports were received. Commander Floyd then polled each Department Officer asking if there were

any additions, deletions, or corrections to their published reports. Treasurer Gib Young reported he had an updated report current to this day. The Department account has \$10,318.95. Several copies of the Treasury Report were available for review by the Encampment. There were no additions, deletions, or corrections to the other Department Officer Reports.

Commander Floyd called attention to the numerous graves to be registered in Indiana and showed a map of the location of cemeteries located in Indiana. He thanked Graves registration Officer David Hoesli for his untiring work performed in doing such an enormous job! Brother Adams and Brother Schmitt commented briefly on the GAR Highway, US 6.

### Camp Reports:

Commander Floyd requested of each Camp Commander present if there were any corrections or deletions to their Camp reports, none were reported.

### **Department Standing Committee:**

**Visitation Committee** update was provided by Brother Tom Schmitt. Brother Schmitt reported he has nothing to report. He did ask for more clarification of the duties of this committee. Commander Floyd explained that the Department By-laws state that a committee of two is to be appointed each year to visit the Orphanage in Knights Town and the Indiana Veterans Home in Lafayette, Indiana. If possible, it should be done in conjunction with other Allied Orders. More discussion to come in the future.

### **Department Special Committees:**

Last Union Veteran Project: Brother Gib Young reported that a "Last Veteran" had been found for each of Indiana's 92 counties however, all graves have not been marked. Gib, reminded everyone that placing a marker at the appropriate Last Veteran's grave is an excellent project for each Camp. He asked that each camp Commander communicate the counties they are marking graves to avoid dual effort. An example was Blackford, county where Camp #17 had purchased a plaque for the grave with the Veterans information, but Camp # 1 performed the ceremony and added the marker. (The camp Commanders involved will resolve outside of the Encampment) Brother LeMaster reported that the Last Soldier listed and who's grave is so marked for Miami County is incorrect. Pvt. William Rennaker is buried in Converse Cemetery and Converse Cemetery is in Grant County. Pvt. Rennaker therefore is not the "Last Veteran of Miami County. The true "Last Veteran" of Miami County is Pvt. Jonathan Jones of the 11<sup>th</sup> Indiana and is buried in Mount Hope Cemetery, Peru Indiana. A **motion** by Brother Teller that we properly honor and mark the grave of the correct Last Veteran of Miami County, Pvt. Jonathan Jones but leave the plaque on the grave of Pvt William Rennaker in the Converse Cemetery. **Motion** seconded by Brother Bruce Kolb; *motion approved!* 26th Indiana Vicksburg Monument: Brother Bill Adams provided an update on the request to move the 26<sup>th</sup> Indiana's Monument back on the VNMP property. Brother Adams explained that the placement of the monument will have to wait until other more serious issues can be resolved at the National Park. Currently the VNMP has 1/3 of the park closed to visitors due to massive erosion problems. Many roads have washed out and the National Cemetery has many graves damaged as well. He reminded everyone of the link that Commander Floyd had sent earlier this year from the National Battlefield Trust. The short video showed the damage and provided knowledge about the severity of the erosion problems. It also provided a link to a letter that will automatically send a letter to the Brother's correct Senators and Representatives. Brother Adams urged all Brothers of the Department to fill in the basic information for that letter so it can be sent urging congress to act by providing funds to correct the erosion problems. Commander Floyd then showed the National Battlefield Trust video to the Encampment.

Department Records Storage: Secretary Adams reported that all Department records are currently sorted and stored in heavy plastic totes. This currently alleviates the most pressing previously listed concerns with storage of Department Records. Brother Drew Godby informed the Encampment of a group he is associated with, the Center for Fraternal Collections and Research that are looking for Indiana Fraternal Organizations to provide free digitation and storage of records and files. Secretary Adams and Brother Godby will meet outside of the meeting to exchange contact information.

Department Projects: Committee Chair Bother Alan Teller said there had been no requests to date. He asked for more information about the committee. It was created out of Treasurer Gib Young's recommendations that the Department had funds that could be used to support Camp projects. Camps can request fund support for projects by directing their requests to Alan Teller and Gib Young.

**Department Insurance Review:** Brother Bruce Kolb explained the review he performed comparing the National Insurance Policy to the Departments Insurance Policy. In all areas of review the Department Policy exceeded coverage as compared to the National. Total area of coverage also exceeded the National Policy. Therefore, Brother Kolb recommended that we continue with our current Department Insurance Policy, Brother Kolb made a **Motion:** That the Department continue to pay the Premium on the current Department Insurance Policy. Support by Brother Alan Teller. After discussion the *motion was approved*.

**Department Encampment:** A new format was tried at this Encampment where by the Department Officers reports and Camp reports were not read. All reports and the minutes were assembled and available for reading before the Encampment. Brother Floyd asked for opinions regarding the changes. Main comments were, the reading of camp reports allowed for new camp ideas to be communicated. Another comment was that only recommendations from the reports should be read. Discussion also occurred about the location and time change of the Annual and Midyear Encampments. After the discussion period Brother Brian Mexin made the following motion supported by Brother Kolb to: Continue with the new format schedule of the Annual Encampment being the last weekend in April at Kokomo. The Midyear to continue as a moving Encampment hosted by the different camps on the first weekend of November. The motion was approved. General Encampment Business: Commander Floyd presented a map locating each Department member living in the state. Individual maps for each specific camp were handed out to each Camp Commander. Camp Commanders were to use this in recruiting new members. Commander Floyd had a brief overview of Memorial University and congratulated Department Secretary Adams for receiving a pin and certificate of completion at the National Encampment. Commander Floyd congratulated Brother Tom Schmitt for becoming a Gold Sentinel Level at the SUVCW Charitable Foundation. Two (2) others from the department, James Floyd and John Eger have also attained this level. Brother Teller explained that the purpose of the Foundation was monument preservation/ restoration, monument construction and erection, scholarships, and benevolence to members of the SUVCW. Commander Floyd noted that by tradition the outgoing Department Commander receives a Past Department Commander badge. He indicated that many Departments now supply this badge with a bar that hangs on the badge with the Name and Department Emblem. Brother Tim Beckman has been sourcing a supplier and designing the bar. He provided an image of the first iteration of the bar. He said it is too large and further revisions are needed. He is using the same supplier that Department of Illinois has used. No actual final costs have been determined but set up costs are \$100. He will continue working the issue and we will review again at the Annual Encampment.

### Old Business:

National Encampment: Commander Floyd congratulated Orlando Somers Camp for receiving the Horace Greely Award for "The most Outstanding Website Design". Camp Commander Travis LeMaster said it was a surprise and the person behind the design was Camp member Brother Drew Godby. Commander Floyd remarked on several various points regarding the National Encampment. He said he was pleased with the turnout for the Indiana Delegation and thanked all who attended. The Commander then commented on the upcoming Remembrance Day events coming up at

Gettysburg. He commented on the NPS rules for the placement of flags on graves in the National Cemetery at Gettysburg. He also provided information on the increasing costs to the SVR to hold the Remembrance parade. City permits alone have increased from \$400 to over \$6000. That's in addition to fees to the State for Police coverage, trash pick up etc. The SVR provides a streamer to anyone who donates a minimum of \$100 toward the cost of the parade. Commander Floyd presented a streamer he received for his donation to the Department Patriotic Instructor Brian Mexin to place on the Department Flag.

Evansville Memorial Coliseum Update: No change to the June 4<sup>th</sup> Annual Encampment report. Sultana Memorial Project: Brother Bruce Kolb presented the history of the Sultana tragedy and gave some background on the project. The project started with Brother Tim Beckman and Brother Kolb to establish a memorial to those victims of the Sultana. The National Veterans Memorial Shrine in Fort Wayne had an unused stone and through the help of Brother Tom Schmitt, the stone was made available for the Sultana Memorial. A bronze Plaque 12'x15" was ordered to attach to the stone. The stone will then be put in place at the Veterans National Memorial Shrine and Museum grounds in Fort Wayne. Total cost for the plaque and mounting was \$669.00. Monies donated to the Ben Harrison Camp from the closing of the Ladies Auxiliary to the SUVCW were to be used to pay for the plaque. However, Brother Alan Teller felt that the Department of Indiana should support this project financially. Brother Teller made the following Motion: The Department of Indiana fully financially support the Sultana Monument project as presented by Brother Kolb. Support from Brother Mexin. One question, was where does the original money marked for the project from the Auxiliary go? Answer, into the Ben Harrison Camp fund. *Motion was approved!* 

Chaplain Alan Teller closed the Bible at 11:40 to adjourn for lunch.

Department Secretary Adams read Indiana Department Order 2022-6 to all Brothers. (See Encampment Proceedings)

Secretary Adams, by direction of Indiana Department Order 2022-6, Convened a Court of Honor for the purpose of the Department bestowing on Sisters Elizabeth Thurston and Penny Bucks, the Dr. Mary Edwards Walker Award. Both are members of the WRC and the LGAR.

Programs presented during lunch:

- Award presented to Brother Gib Young for support of the Last Veteran Program and his years of service as the Editor of the Legion
- Award presented to Brother Tim Beckman for support of the Last Veteran Program and his years of service compiling the Legion.
- Award presented to David Hoesli for the outstanding work by John Foster camp in preserving the records from the GAR Room at the Memorial Coliseum, Evansville, IN.

### Return from lunch:

**Kimmel Park LGAR/DUV Monument:** Vincennes Update: No change to previous report of June 2022.

Oscar & Molly Mott #1 WRC Corps: Brother Adams reviewed the activities at the Chartering Ceremony for the Oscar and Molly Mott #1 WRC Corp. The Oscar and Molly Mott #1 WRC Corp currently is the only WRC Corp active in Indiana. Adams also reported that 7members of the 27<sup>th</sup>

SVR presented Colors and fired a rifle volley. It was also noted that Elizabeth Thurston and Penny Bucks did an excellent job organizing the day's events.

**Thomas Cave Last Union Veteran:** Brother David Hoesli gave a review of the Thomas Cave LUV of Orange County Ceremony held August 28<sup>th</sup>. Four of Thomas Cave's descendants attended as well as 10 SUVCW. Commander Floyd noted that Thomas Cave is pictured briefly from a news clip of that time attending the 1938 Gettysburg Reunion.

Last Union Veteran of Blackford County: Commander Floyd called on Sommers Camp Commander Travis Le Master to give an update. The LUV of Blackford County was James Augustus Alfrey of Company I, 132nd Indiana Infantry. Brother LeMaster noted that 19 descendants of James Alfrey attended the ceremony September 11, one attending from Virginia Beach, Virginia.

Eliza E. George Memorial Service: Brother Tom Schmitt reported on this program and ceremony that he organized to honor Civil War Nurse Eliza (mother) George. The ceremony was held at the Mother George Monument placed in her honor at Lindenwood Cemetery, Fort Wayne, Indiana. Brother Schmitt was supported by 7 Veterans from the Veteran's Memorial Shrine and Museum, the 30<sup>th</sup> Indiana Volunteer Reenactors, the 27<sup>th</sup> Indiana SVR, the ladies Allied Orders of the WRC, LGAR, and the SUVCW. Commander Floyd commented on the excellent job Brother Schmitt did in bringing together such a well-run program.

**The Indiana Legion** New Legion Editor Brother Jon Swarts thanked everyone who contributed articles to the most recent Legion. He said the goal was to publish the Legion 4 times per year in January, April, June, and October. He stressed that to do that he needed everyone to contribute articles and pictures.

**Upcoming SVR Events:** Brother Adams explained that all upcoming events were marked on the SVR Activities Calendar. He did note that there was a change to the December 17<sup>th</sup> Wreaths Across America event as listed. Bruce Kolb, the officer in charge of the event explained that there was a change in locations this year. This year the 27<sup>th</sup> were invited to support Wreaths Across America at Williams Creek Cemetery in Indianapolis.

**Camp Officer Installation:** Commander Floyd announced that it was his preference to install the camp officers. It is his way to visit all camps and get acquainted. He said a number of camps have contacted him already and if at all possible, he will attend. If he is unable to attend, he will appoint a Past Department Commander to take his place.

### **New Business**

**Department Seal:** Secretary Adams explained that the old embosser used to imprint the Seal of the Department of Indiana on a document was no longer legible. A new embosser was purchased. (New embosser displayed to Encampment) The new embosser is light weight and compact while the old one was heavy and bulky. Commander Floyd explained that replacement of the seal began because he wanted to digitize the Department seal and needed an image of it. Since the old one was illegible, he could not do that. The decision was then made to purchase the new seal embosser.

Reimbursement of Department Officers: Commander Floyd brought this subject to the Encampment because for years the Department Officers had paid expenses incurred for Department business out of their own pockets. He said if we had only \$500 in the Treasury he wouldn't bring the subject up, however that is not the situation. He then submitted to the Department Treasurer receipts for the Mary Edwards Walker medals and the receipt for the new embosser. He also submitted Secretary Adams receipt for the Encampment ribbons. Brian Mexin made a motion supported by Brother Alan Teller stating that the department reimburse both Commander Floyd and Secretary Adams the amount submitted on the receipts. *Motion passed* Commander Floyd then stated that he had requested Department Secretary, Brother Adams to develop a list of all his costs incurred from January 1, to October 29, while doing the Department's business. The itemized list totaling \$149 was presented to the Encampment and Department Treasurer. Brother Mexin with support from Brother Bill Bierly made the following Motion: That Department Secretary Adams be reimbursed \$149 for his department expenses. Alan Teller questioned if we could reimburse this amount without receipts

per IRS requirements. Commander Floyd explained that we could and how we could do that. *Motion passed*. All future Department expenditures requesting reimbursement <u>must</u> be accompanied by a receipt.

Station Banners and Tables: Commander Floyd pointed out that the Encampment was set up with the Officer stations and Station Banners. The Station Banners used today belonged to John Auten Camp and those used in June belonged to John W. Foster Camp. The Commander asked if the Department wished to spend \$180.00 to purchase a set of Banners for the Department or to continue with borrowing them from camps? Brother Tim Beckman supported by Brother Travis LeMaster made a Motion: That the Department purchase a set of Station Banners for Department use. Also, that they are added to the Departments inventory list as Department property. After a brief discussion a voice vote was taken. The vote, to close to determine, was then taken by a show of hands. Brother LeMaster and Brother Adams each counted the votes independently and confirmed the totals matched. Final vote was 13 Yea, 11 Nay, and 1 abstention. *Motion passed*.

**National Encampment Streamers:** National has authorized, starting with 2000 that an Encampment Streamer be presented to the Departments that host a National Encampment. Departments that hosted a National Encampment before 2000 may purchase the streamers at a cost of \$70 - \$75. Commander Floyd asked if the Department wished to purchase streamers for the 8 times previous to 2000 when Indiana hosted the National Encampment. Brother Kolb recommended that this item be tabled until the April Annual Encampment in 2023. So, *approved*.

General Orders #5 & #7: Commander Floyd explained General Order's #5 & #7. G.O. #5 stated that all hereditary new members are required to submit copies of official documents (birth & death certificates, marriage licenses, etc.) to support lineal membership. It also required that a copy of the applicant's driver's licenses be included. G.O. #7 was similar to #5 except that it removed the requirement of a copy of the driver's license and added that the applicant must show their drivers license to the Camp Secretary. There was over 30 minutes of discussion on this topic all opposing the requirements set out in General Order's #5 & #7. (a digital recording of the encampment is available for more detail on this discussion) Commander Floyd stated his opposition due to the lack of 2<sup>nd</sup> and 3<sup>rd</sup> order effects thinking. He pointed out that there are numerous issues of costs, time, storage, and availability of the documents to many. Brother Alan Teller voiced his opposition on similar issues but also noted that it would impact future recruitment in the SUVCW. Brother Kolb pointed out the issues with protecting personal information of the nature required and how to store it securely. Secretary Adams said that in his opinion this showed a complete lack of leadership on the part of the Commander-in-Chief. This confirmed by the CinC not requiring more study and input from the Brothers of the Organization on the ramifications of such a General Order.

Changes to Department By-Laws: This subject came to the agenda by Commander Floyd due to the Visitation Committee's requirement to visit both the Knights Town Orphanage and the Indiana Veteran's Home in Lafayette. (See Standing Committee's reports). Since the Orphanage in Knights Town no longer exists the By-Laws will require a change. Brother Teller asked that this subject be tabled to a future time. All Department By-Law changes must be approved by the Commander in Chief and Alan felt that the Commander-in-Chief might make the approval very difficult. This Alan said was based on the comments and position the Department of Indiana has taken regarding General orders #5 & #7. Discussion tabled.

Bonding of Department and Camp Officers: Commander Floyd explained that the National Constitution and Regulations (C&R) requires all Camp and Department Officers handling money must be bonded. He said currently the Department of Indiana is not doing that and we are in violation of the C&R. Brother Bruce Kolb had previously been directed by the Commander to investigate the bonding issue. Brother Kolb reported that in Indiana the Secretary and Treasurer of the Camps and Department must be bonded. The amount of the bond is to be determined by the Department Council. He then explained the three types of bonds and explained why the Fidelity bond type was correct for our situation. The Department Liability Insurance Carrier, State Farm Insurance, is able to provide the Fidelity Bond. The cost is based on the amount of coverage ranging from \$5,000 to \$50,000. Chaplain Alan Teller made a motion supported by Brother Mexin. Motion: to purchase Bonding Insurance for the Department and Camp Officers who handle money in an

amount determined by the Department Council. *Motion approved*. Following the vote, the Department Council determined that the amount covered would be \$50,000.

**Eliza Ann Hardy-Boston:** Commander Floyd mentioned that during the Mother George Dedication information was referenced to another similar Civil War era nurse, Eliza Ann Hardy-Boston. She is buried in Pendleton Cemetery. He would like to see a dedication similar to Mother George for Eliza Ann Hardy-Boston. This should be done in cooperation with the Allied Orders. More to come on this.

### Other New Business:

- Brother Randy McNally requested that the Department help spearhead approval of a
  certificate similar to the Eagle Scout for the Trail of Life program. Commander Floyd
  directed that the information be given to Eagle Scout Coordinator Brother Michael Beck to
  begin the process.
- Alan Teller presented a brief history about Veterans Day.
- David Hoesli volunteered John W. Foster Camp #2, Evansville to host the 2023 Midyear Encampment. There being no other Camps interested in hosting, John Foster Camp was approved to host the 2023 Midyear Encampment
- Brother Dennis Rigsby announced that William Benton Camp #28 will be conducting a Last Veteran of Wayne County Dedication at noon on Veterans Day this year.
- National Rep Bobby Welch, PCC congratulated the Department on a well-run and informative Encampment. He mentioned that he was holding a Memorial University training session. It would have live instruction and computers available to enhance the learning experience. It is planned for some time in December at Tinley Park II. He invited everyone who would like to attend.

There being no further business to bring before this Encampment Commander Floyd proceeded to the closing ceremony. The Colors were retired and the meeting properly adjourned.

### **Mid-Year Graves Registration Report**

May 31, 2022 – October 15, 2022

To: Department of Indiana Secretary, William Adams, PDC

I have the honor to report the status and activities of the Graves Registration Officer for the Department of Indiana from May 31 through October 15, 2022.

As of October 15, 2022, there were a total of 37,772 Civil War soldiers buried in Indiana who were registered on the National Graves Registration database. This reflects a decrease of 1,405 registrations within the database. The substantial decrease was due in large part from the removal of duplicated registrations in Owen and Wayne counties. These duplications were entered during the early startup of the National Graves Registration database and does not reflect the current practices of the Brothers of the Department of Indiana. Most of the increases that help to offset these losses were in Shelby County, Indiana having added 54 new veterans followed by Tippecanoe County 48 and Floyd County 44. Consequently, 52 out of Indiana's 92 counties contributed to the increase. The overall total is based on an "Indiana" search only. A search by individual counties reflects a different total of 37,043. This is due in large part to veterans entered without a named county or misspelled county names. The following data is a break down by-county.

The accumulated total of 37,772 is inclusive of 729 Indiana registrations that remain without a county name. The effort to remove or update these discrepancies is ongoing. In doing so, these reductions in duplicates and errors will offset any gains that a county may have uploaded to the database as well as any overall totals.

Removals since May 31, 2022, were as follows:

*Wayne County* – 926 duplicates were removed. The end total though was 918 indicating that some of the loss was offset by gains in registrations since May 31, 2022.

Owen County – 867 duplicates were removed in all. 850 registrations were removed due to the Owen County name being placed in the "city" box instead of the "county" box. While this didn't create any loss by county tabulations, it did create a loss for the overall Indiana total. Upon inspection of those same names, they were also found to be duplicates already in the database. Another 17 entries that had the correct county name entered were also duplicate entries and were also removed.

Other Counties – 36 additional removals from several other counties were completed but offset by gains in new registrations

The previous total of 39,177 from May 31, 2022, less the previously mentioned removals totaling 1829 then adding in the gains of 424 gives us our current total of 37,772 Indiana veterans in the database and would be in my opinion the most accurate less any additional duplicates.

In conclusion, as mentioned in my past discussions, the effort here is to not only register as many Civil War veterans as possible on the National Registry, but to do it in a manner befitting of the service these Veterans have given to protect our Union. The goal is quality of quantity. The reduction in errors thus far has been reduced from 2,558 to just 729 and it is my hope that soon we can honestly say the Indiana entries in the National Graves Registration database is the most quality and complete record we can ask for.



The John W. Foster Camp No. 2 was represented at the annual Indiana Department Encampment in Kokomo, Indiana by Commander David Hoesli and then Department Commander Dennis Hutchinson. The two members of the Camp participated in the elections of the new Officers and all business that came before the Encampment.

# Representation of the Camp and SUVCW in the Community

<u>Lincoln Pioneer Village Heritage Days</u>, October 29, 2022 – Dennis Hutchinson – PDC and Secretary to the Camp will be presenting a Civil War Living History with tent, muskets, accourrements etc. for the public at the Rockport Lincoln Pioneer Village Heritage Days at Rockport, IN. During the event Dennis will be giving information about the John W. Foster Camp No. 2 and the SUVCW.

# Last Veteran Project

The John W. Foster Camp conducted a Last Veteran ceremony honoring the last soldier of Orange County, Indiana. Sgt. Thomas J. Cave, a member of Co. E, 18<sup>th</sup> Indiana Infantry was born in Dubois County, Indiana 11 September 1844 and passed away on 7 December 1940. He attended the 75<sup>th</sup> Gettysburg Reunion at age 95 and has been identified in the 75th Gettysburg Reunion videos. The Last Soldier Dedication honoring Sgt Cave was held August 29, 2022, at Ames Chapel Cemetery in Paoli, Indiana. Attending were at least eight members of the Sons of Union Veterans of the Civil War 27<sup>th</sup> Indiana SVR, twelve members of the American Legion Posts No. 76 and 149 near French Lick, three members of the 18<sup>th</sup> Indiana Light Artillery reenactment group, four family members of Sgt Cave. Five Indiana Camps were represented in the participating groups. Also in attendance were two members of the Fort Duffield Camp No. 1 of the Kentucky Department of the Sons of Union Veterans of the Civil War. Approximately 25 citizens attended the ceremony. Indiana Department Commander Jim Floyd ended the ceremony with a discussion about Sgt Cave and the Sons of Union Veterans of the Civil War.

# Cemetery Projects

Bellefontaine Cemetery, Mt Vernon, Indiana: The John W. Foster Camp has embarked on a large-scale cemetery project that has resulted in the applying for and receiving 74 new military headstones in addition to another 67 new markers yet to be applied for. In all, there will be 152 replaced and reset headstones within the Soldiers Row at Bellefontaine. Approximately one quarter of the soldiers buried at Bellefontaine died at the Mt. Vernon, Indiana U.S. General Hospital during the Civil War. The remaining number were buried after the war and include a small number of Spanish American war veterans as well as one Indian War and WW I veteran. The research to find unknown named soldiers has been ongoing since February of 2022. Installation and resetting of the headstones began in early May with the first three rows nearly complete. The Foster Camp has been working side by side with the Sons of the American Legion Post in Mt. Vernon, Indiana to complete the project.

Oak Hill Cemetery, Evansville, Indiana: The John W. Foster Camp is currently working on the construction of two metal cannon carriages to replace the older wooden carriages that have fallen apart. The goal is to have the cannons that have sat in Section 24 since 1872 back in the section by next summer. In addition to the replacement carriages, the Camp will be cleaning and straightening the headstone in addition to painting the mounted siege cannons, mortars, and the fence.

# Coliseum GAR Farragut Post #27 Records

The GAR records previously stored at the Evansville Coliseum have now been removed to the University of Southern Indiana and all records of the Farragut Post #27 except for the death records and two cash books have been microfilmed and have been uploaded to the archive's website at Rice Library. Yet to be completed are the Women's Relief Corps and the Daughters of the Union Records.

#### **Grave Memorial Ceremonies**

<u>Headstone Dedication Ceremony</u>, October 15, 2022, headstone dedication to Revolutionary soldier Private Johan Frisbee. Private Frisbee was a Drummer in the 1<sup>st</sup> Massachusetts Regiment. He is buried in the Frisbee Cemetery at Yankeetown, IN. In attendance were Commander David Hoesli and Brother Dennis Hutchinson, PDC.

<u>Bellefontaine Cemetery, Mt. Vernon, Indiana,</u> A dedication ceremony is slated for next Memorial Day, 2023 for the approximately 152 headstones that we believe will be completed by that date.

## Summary

The decrease in the Covid-19 has eased the restrictions the Camp has endured over the past couple years allowing the Camp to raise membership, complete projects, attend and organize events. The Camp activity has picked up and has taken on larger and more aggressive projects that require more involvement of the entire Camp. The endless efforts of the Camp to follow through with the digitalizing of the Farragut Post G.A.R. records, the resetting and replacement of 152 military markers, as well as the replacement of two cannon carriages at the Civil War section at Oak Hill Cemetery only proves that the Camp is committed to following through the promise of carrying on the tradition of the Civil War veterans. June 21 Brother Young spoke about the Civil War and the SUVCW before a group of Jasper County historical society members.

Aug. 10 Brother Young spoke before a group of residents at the Victory Knoll St. Anne's Senior Residence in Huntington about the Civil War and the SUVCW

August 15 Nine markers for the graves of the last Union soldiers/sailors in nine northeast Indiana counties have arrived and are awaiting the final touches before members of Camp 17 place them on the appropriate soldier's grave.

Sept. 9 Brother Young was interviewed by a reporter for Channel 8, WISH TV, for a segment on Indiana and the Civil War. The interview took place in the GAR room of the Huntington County Courthouse.

Sept. 22 Brother Young talked to the Fairfield Township Trustee in Tippecanoe County about coming to the historic Greenbush Cemetery and cleaning and resetting CW headstones. The township people are ok with members of Camp 17 doing this. Greenbush has dozens of veterans buried there including Col. Carroll of the 10<sup>th</sup> Indiana (killed at Chickamauga), William Thompson of the 20<sup>th</sup> Indiana (a MOH winner), and a score of Federals and Confederates buried close together.

Sept. 25 Brother Young spoke to people at the Huntington Pioneer Festival and handed out pamphlets for the SUVCW.

Oct. 11 Several members of Camp 17 placed plaques on the graves of 'Last Soldiers' in Wells County and in Allen County. The soldiers were Pvt. Cyrus V. Young of the 3<sup>rd</sup> Ohio Light Artillery who is buried in the Haverstock Cemetery at Zanesville in Wells County and Pvt. Richard G. Foss of Co. A, 16<sup>th</sup> Pennsylvania Cavalry who is buried in Lindenwood Cemetery in Allen County. Several local people and the Bluffton newspaper attended the event at Zanesville.

Oct 22 Brothers of Camp 17 participated in the Mother George dedication ceremony in Lindenwood Cemetery in Ft. Wayne.

Oct. 25 Several members of Camp 17 placed plaques on the graves of 'Last Soldiers' in Adams County and in Jay County. The soldiers were Private William Parr of Co. E of the135th Ohio National Guard who died in 1939 and is buried in the Willard/Mt. Hope Cemetery east of Berne in Adams County and Private Jason Downing of Co. K, 154<sup>th</sup> Indiana Infantry who died in 1941 and is buried in the Green Park Cemetery in Portland in Jay County. As at the previous two grave sites a short ceremony was held on the spot.

# **Department Encampment Special Committee Report**October 29, 2022

Brothers of the Department of Indiana:

At the 136<sup>th</sup> Annual Encampment of the Department of Indiana, SUVCW held June 4, 2022 in Kokomo, Indiana, discussion ensued about changing the dates of the Department Annual and Mid-Winter Encampments. This is a continuing discussion as (at least) Past Department Commanders Tim Beckman and Dennis Hutchinson have raised this topic. The discussion also prompted the idea of having only one Department Encampment per year. Based on subsequent analysis of data from the past fifteen years of Encampments, it is the opinion that we should continue holding two encampments at this time.

The end goal is to make Encampments be events you look forward to attending and that ALL Camps in the Department participate in.

The Annual Encampment is currently held the first Saturday in June. This we believe is not an optimal choice of date. June, July, and August are typically family vacation months. Additionally, hotel costs are higher during this time of year. The consensus of the discussion during the 136<sup>th</sup> Annual Encampment was to test changing the dates of the upcoming Encampments. The Encampment Committee tentatively looked at November 5, 2022 for the newly titled Mid-Year Encampment and April 29, 2023 for the 137<sup>th</sup> Annual Encampment of the Department of Indiana, SUVCW. NOTE: The actual date of the 2022 Mid-Year Encampment was changed to October 29, 2022 because of a Notre Dame Football home game on November 5<sup>th</sup>.

The change in the date from the last weekend of January to the first weekend of November should alleviate travel issues due to snow and ice, and overall avoid potentially bitter temperatures. It is the intention that the (now) Mid-Year Encampment will continue to be hosted by Camps who volunteer to do

so. The change in the date from the first Saturday in June to the last Saturday in April should avoid school summer vacations, Easter, and provide lower hotel costs. Additionally, Department submission of Form 35 to the National Executive Director is required by May 31<sup>st</sup> each year, so the date change will assist the Department Secretary in meeting that deadline. Current plans are to keep the Annual Encampment in Kokomo.

There are other changes to the Encampments as well.

The Encampments will return to being more like the G.A.R. Encampments. That means ritual, entertainment, fun, business transaction, patriotism, and fellowship.

Minutes, Department Officer, and Camp Reports will no longer be read out loud. Submission of written reports from Camps, Department Officers and Department Committees **remain required** and they will be complied as a part of the Encampment Proceedings for reading by anyone who wishes to do so.

Encampments will include a presentation on an interesting topic, a short patriotic instruction, and at least one activity (such as PDC Gib's trivia games) that provides the opportunity to win a prize.
