Commander-in-Chief Meeting with Department Commanders

Commander-in-Chief Bruce Frail called a meeting of Department Commanders on January 30, 2023.

There were several items on the agenda however, I will focus on two for this circular. The first is a Special National Committee to Review Membership Qualifications report on revising the SUVCW Constitution. The recommendations of the Committee are to amend the language regarding eligibility of membership. Please read the report as it will likely be addressed by Brother Hritsko at our Encampment.

The second was in-depth conversation about the lineage documentation requirements, originally outline in General Order #5, revised in General Order #7, and revoked in General Order #13. I stated our concerns regarding the implementation of these new documentation requirements. Some Departments concurred with my comments, and some did not. In the end, the majority of Departments on the call stated they are in favor of the lineage documentation requirement and that they perceive minimal or no burden in its implementation, so I anticipate this will be enacted at the National Encampment. Again, this will likely be discussed by Brother Hritsko at our Encampment.

It was my honor to install Camp officers for John W. Foster Camp No. 2, Ben Harrison Camp No. 356, and Orlando A. Somers Camp No. 1, John B.
